With the passage of the fourteenth amendment of the Constitution, constitutional government was recognized in all states. These states were split into two groups, a moderate group in the Northeast, with Massachusetts, New York and Connecticut, which promoted the principle of popular sovereignty, and the radicals in the South, which promoted the idea of a federal union. New York[edit] The New York Civil Rights Law, and the Enforcement Act of 1871 "Vouchsafe protection", require public schools to be integrated. The New York Civil Rights Law [edit] The New York Civil Rights Law prohibits discrimination in public accommodations, defined in Section 54 of the New York State Executive Law, which includes certain accommodations, such as hospitals and lodging establishments, and all places of public accommodation, defined in Article Six of the New York State Executive Law, including all places of public accommodation in New York City, places of public accommodation in Long Island and in Westchester County, and the hotels, boarding houses, and inns in New York State, where lodging is received, provided for, or otherwise extended, in these various places of public accommodation. Section 54 - Access to public accommodations, hotels, restaurants and lodging establishments. - No person shall, because of the race, creed, color, national origin, sex, disability, or ancestry of any person, be denied the full and equal enjoyment of the accommodations, advantages, facilities, and privileges of any place of public accommodation, as defined in subdivision one of this section. The New York Civil Rights Law [edit] Section 44-a of the New York City Administrative Code, the New York State Human Rights Law Section, and the New York State Executive Law Article 6 prohibits discrimination in employment by private employers. Section 12 - Employment. - No employer shall discharge, refuse to hire, or otherwise discriminate against an individual with respect to his compensation, terms, conditions, or privileges of employment because of such individual's race, creed, color, national origin, sex, or disability, or because such individual has exercised or threatens to exercise any right afforded by this article or by the United States Constitution. No State shall make or enforce any law which shall abridge the privileges or immunities of citizens of the United States; nor shall any State deprive any person of life, liberty or property, without due process of law; nor deny to any person within its jurisdiction the equal protection of the laws. The Fourteenth Amendment to the Constitution of the United States grants these rights. The privilege or
