NAB Jails Hakeem al-Araibi, the 75-year-old refugee facing extradition to Saudi Arabia to face "terrorism-related charges" in a criminal case "instigated" by Riyadh, as the kingdom makes good on its threat to cut off diplomatic relations with Australia. "He is being detained by a private security firm, but the Australian embassy is aware and is aware of the criminal charges," Foreign Minister Marise Payne told reporters in Sydney on Tuesday. "We're actively pursuing his release." Hakeem al-Araibi, a refugee from Bahrain, remains in a Nauru detention centre after fleeing Australia in 2015 and has been in immigration detention in Thailand for four months after being granted bail by a court in that country. Saudi Arabia has denounced his release as "a mockery of justice" and a "hostage situation", and has retaliated against Australia by halting its diplomatic relations. "It's an indication that it's not going to be enough to get him released that he has already been in Thailand for more than six months," Payne said. "What we want to do is just ensure that he gets a fair trial in Thailand." The foreign minister said that if Thailand were to refuse to allow al-Araibi to leave the country to face criminal charges, the Australian government would consider "all options available" to him. "We do not agree that bail should be granted as part of a criminal charge. It is completely contrary to Australian law, it goes against all of our laws," she said. "There's no question he has a right to a fair trial and if he's not provided with a fair trial in a timely manner he will be released."
