Mr. Guillon contends the Board erred in finding his claim barred because the applicable statute, the Black Lung Benefits Act, 30 U.S.C. Secs. 901-45, does not explicitly state that the one-year period commences when the employer receives written notice of the claim and the claim's denial. The Board's decision is supported by substantial evidence. We affirm. 2 Mr. Guillon filed an initial claim for benefits on May 26, 1983. He received a Notice of Denial on June 27, 1985, which stated that he had not filed a timely claim for benefits because he had received written notice of the claim's denial only on June 26, 1983. Mr. Guillon disagreed with the application of the time limitation and requested a formal hearing before an ALJ. He subsequently received a Notice of Hearing which set the formal hearing for January 9, 1986. On April 6, 1986, Mr. Guillon mailed a letter to the ALJ and stated that he did not receive the Notice of Hearing until that date, he believed he 3e33713323
