This means that I avoid getting into more advanced features of Photoshop because they require an in-depth knowledge of the program. So if you're just starting out with Photoshop, this chapter is all you need to know. (For more information about using the more advanced features of Photoshop, see Chapter 18.) Photoshop's main work area You start work in Photoshop using the main work area, the canvas, as shown in Figure 3-1. **Figure 3-1:** The canvas is the workspace. Before you begin work, Photoshop opens the Preview (shown in the margin) so that you can see exactly how your changes will look. If you are creating a raster image, you can zoom in to 1200 percent by clicking the zoom in button at the top left of the Preview panel. You create, manipulate, and save your image in the areas highlighted in Figure 3-2. To create an image, choose the option. You can also use the keyboard shortcuts Ctrl+N or choose File→New. **Figure 3-2:** Create, manipulate, and save in the areas highlighted. To save a document, choose File⇒Save; or press Shift+Ctrl+S. If you're saving an image, the defaults are size 12 (in inches). If you're saving a path, the size defaults to width 400 pixels. You can save the image as a JPEG, an EPS, a PSD, a GIF, a TIFF, or a PDF. The TIFF and EPS files are vector formats and can be opened in many other types of programs, including Illustrator. While the interface is geared toward creating and manipulating images, you can also use it to work with bitmap layers. In the areas highlighted in Figure 3-3, you perform various tasks to a layer. The areas used to create, edit, or save a layer are the same as those used for creating, editing, and saving an image. However, you can also navigate the Layers panel by double-clicking the thumbnail of a layer or selecting it and pressing the Esc key on the keyboard. **Figure 3-3:** You can work with bitmap layers in the Layers panel. Effects of swim training on cytokine production in patients with coronary artery disease. Exercise training affects both the innate and adaptive immune systems of the body. A number of pro-inflammatory cytokines have been implicated in the pathogenesis of atherosclerosis. Exercise training was shown to modulate inflammatory and anti-inflammatory responses in vitro. The aim of this study was to test the effects of swimming in the presence of a sedentary lifestyle on the release of pro- and anti-inflammatory cytokines in serum and on arterial wall biopsies from patients with coronary artery disease (CAD). Twenty patients with CAD were randomized to swimming or sedentary control group. Blood samples were collected before the start of the intervention and after 12 weeks. Tissue samples were taken at baseline and after 12 weeks. Levels of cytokines were measured by flow cytometry, the angiogenic and apoptotic cytokine profile was determined by gene expression microarray analysis of arterial wall biopsies. The results showed decreased levels of the pro-inflammatory cytokines TNF- α and IL-6 and higher levels of anti-inflammatory cytokines IL-4, IL-10 and IL-13 in the exercised group compared to the control group ($p \leq 0.05$). Moreover, the exercise group also had higher gene expression levels of vascular endothelial growth factor-A, IL-4, IL-10, IL-13, matrix metalloproteinase-1, matrix metalloproteinase-3, and vascular cell adhesion molecule-1, indicating a remodeling of inflammatory and anti-inflammatory stimuli. These data support the idea that exercise training affects a number of cytokines and may provide mechanistic information on the relationship between physical activity and cardiovascular disease. required by the statutory right to appeal.
