Sec. 1983 action. Myers alleges that his constitutional rights were violated while he was an inmate at the Northern Correctional Center ("NCC") in Napanoch, New York. Myers alleges that defendants (1) denied his right to due process by denying him liberty interest status; (2) did not provide him with due process; (3) violated his right to be free from cruel and unusual punishment by depriving him of adequate shelter; and (4) deprived him of personal security by acting with deliberate indifference to his safety. We have jurisdiction under 28 U.S.C. Sec. 1291 and affirm in part, reverse in part, and remand. I. 3 Myers contends that his due process rights were violated by defendants' failure to give him liberty interest status. This claim lacks merit. An inmate has no liberty interest in a particular prison. Olim v. Wakinekona, 461 U.S. 238, 245 (1983); Ramirez v. Galaza, 334
