Ghiorghiu published a description of the site in the Bulletin of the Palestine Exploration Fund, in which he named it "Tel Najjara". The remains, found in two layers, include a masonry wall, gate, cistern and latrine. During the first excavation, only a general view of the site was presented, which was later revised by Eitan Elad in 1981.
