Before the Court are motions for partial summary judgment by the plaintiffs and the defendant. Plaintiffs' motion for partial summary judgment is denied. Defendant's motion for summary judgment is granted. I. Background Defendant General Motors Corporation ("GM") removed this case from the 69th Judicial Circuit in Macomb County, Michigan on the basis that complete diversity of citizenship existed. Plaintiffs, Michigan Associations of Chemical Pensioners and Trust Funds ("MACPF") and Macomb County Sheriff's Department Pension Fund ("Pension Fund") are Michigan retirement systems or retirement funds which claim, pursuant to the Employee Retirement Income Security Act of 1974 ("ERISA"), that GM's actions have violated the fiduciary duty imposed upon it as trustee of a money or property fund established as part of an employee benefit plan. II. Analysis Plaintiffs seek a declaratory judgment that they are entitled to seek payment of interest, and that interest be awarded to them upon GM's failure to pay them the money to which they claim entitlement. As a fiduciary, GM owes this duty to MACPF and the Pension Fund. Courts can enter a declaratory judgment only if a "case or controversy" exists. See, e.g., Public Serv. Comm'n of Utah v. Wycoff Co., 344 U.S. 237, 244, 73 S.Ct. 236, 97 L.Ed. 291 (1952). There is no case or controversy here. In 2001, this Court found that the plaintiffs have no claim because GM did not breach its fid
