Process of Business Name Registration in Nigeria

5. Obtain a Tax Identification Number (TIN) - Every registered business must have a TIN obtained from the Federal Inland Revenue Service (FIRS). The TIN is used for tax purposes and is required for opening a bank account and other business transactions.
6. Register for Value-Added Tax (VAT) - If the business is engaged in taxable activities, it must register for VAT with the FIRS.
